#### **ERMS & CONDITIONS**

1. Contractors would be required to register on the e-Procurement Market place at the 'e' market Place www.eprocurement.gov.in in addition to their respective registration and submit their Bids online. The tenders can view / download the tender schedules from the 'e' market place www.eprocurement.gov.in at free of cost.

## 2. Charges payable to M/s.C 1 India Private Limited:

The participating bidders will have to pay transaction fee @ 0.03% of ECV (Estimated Contract Value) + 18.00 % GST over transaction fee to M/s.C 1 India Private Limited. All the participants shall electronically pay the transaction fee to the service provider through "Payment Gateway Service on e-procurement platform". The Electronic Payment Gateway accepts all Master and Visa Cards issued by any bank to facilitate the transaction.

- 3. As per the G.O.Ms. No. 174, Irrigation & CAD(PW-Reforms) Department, Dated:01.09.2008, Submission of original Hard Copies of the uploaded scanned copies and EMD by participating Bidders to the tender Inviting authority before opening of the price bids be dispensed forthwith. All the Bidders shall invariably upload the scanned copies of required documents in e-Procurement system and this will be the primary requirement to consider the bid as responsive. The department shall carry out the technical bid evaluation solely based onthe uploaded certificates/ documents, EMD in the e-Procurement system and open the pricebidsofthe responsive Bidders. The Department will notify the successful Bidder for submission of Original hard copies of all uploaded documents prior to entering into agreement.
- 4. If any successful bidder fails to submit the original hard copies of uploaded certificates / documents, EMD Amount paid through on line payment within the stipulated time or if any variation is noticed between the uploaded documents and the hard copies submitted by the bidder, the successful bidder will be suspended from participating in the tenders on e-procurement platform for a period of 3 years. The e-Procurementsystem would deactivate the user ID of such defaulting successful bidder based on the trigger / Recommendation by the tender Inviting Authority in the system. Besides this, the Department shall invoke all processes of law including criminal prosecution of such defaulting bidder as an act of extreme deterrence to avoid delays in the tender process for execution of the development schemes taken up by the Government. The information to this extent may be displayed in the e-procurement platform website.
  - **5.** Submission of Bids: The bidders who are desirous of participating in 'e' procurement shall submit their technical bids, price bids etc., in the standard formats prescribed in the tender documents, displayed at 'e' market place.

- 6. The tenderer is subjected to be black listed and the EMD forfeited if he is found to have misled or furnished false information in the forms / statements / certificates submitted in proof of qualification requirements or record of performance such as abandoning of work not properly completed in earlier contracts, inordinate delays in completion of the works, litigation history and / or financial failures and / or participated in the previous tendering for the same work and had quoted unreasonable high bid prices. Even while execution of the work, if found that the contractor has produced false / fake certificates of experience he will be black listed and the contract will be terminated.
- 7. The Bidders shall furnish a declaration in online stating that the soft copies uploaded by them are genuine. Any incorrectness/ deviation noticed will be viewed seriously and apart from cancelling the work duly forfeiting the EMD, criminal action will be initiated including suspension of business.
- 8. The price-bids of such Bidders, who are determined to have with the eligibility criteria, will only be opened.
- **9.** If the office happens to be closed on the dates specified above, the respective activity will be performed at the designated time on the next working day without any notification.
- **10.** The Bidder shall authenticate the bid with his digital certificate for submitting the bid electronically on e-Procurement platform and the bids not authenticated by Digital certificate of the Bidder will not be accepted on the e-procurement platform.
- **11.**APSRTC reserves the right to cancel, split and award / post pone / reject any, or all the tenders in part or full without assigning any reason what so ever. No correspondence will be entertained in this regard. Any claim by any tenderer in regard to their investment in submission of their tenders will not be entertained.
